EXTINGUISHING MEDIA:

WASH SPILLAGES INTO AN EFFLUENT TREATMENT PLANT OR PROCEED AS FOLLOWS. CONTAIN AND COLLECT SPILLAGE WITH NON-COMBUSTIBLE, ABSORBENT MATERIAL E.G. APPROPRIATE ENGINEERING CONTROLS:
